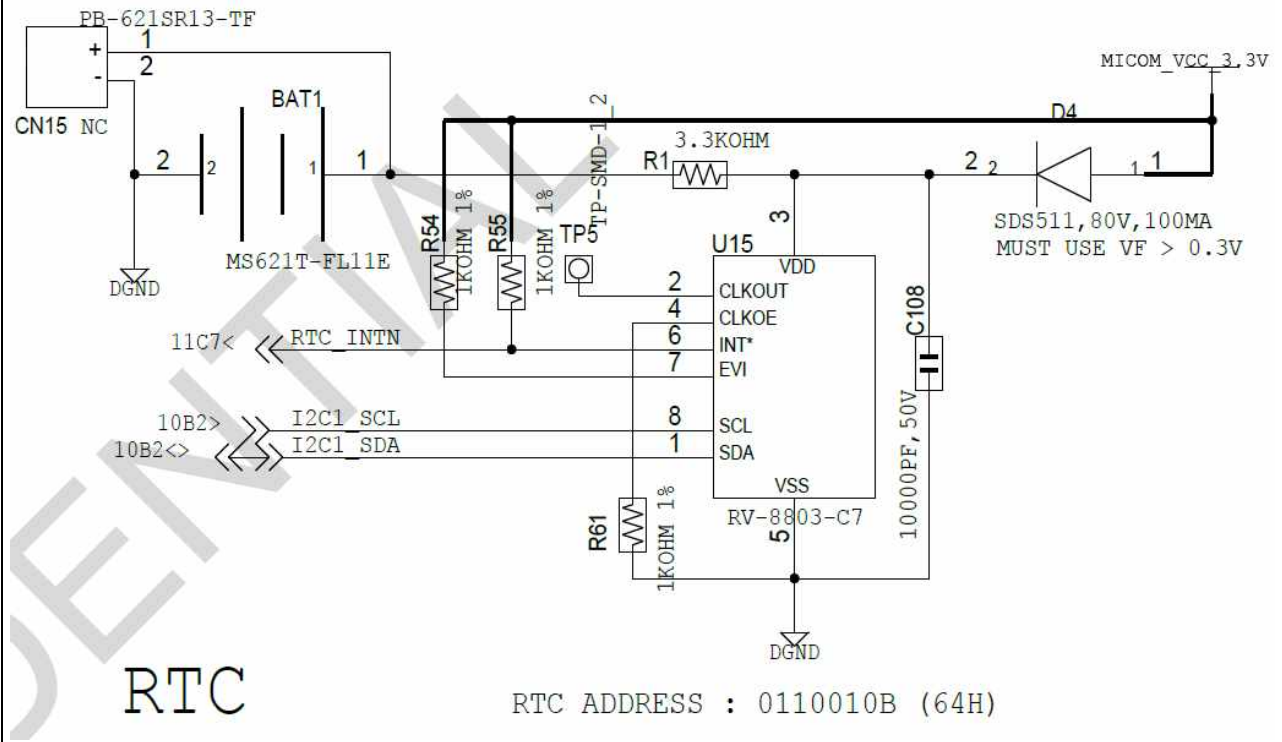

< DC fan view in HDD slot >

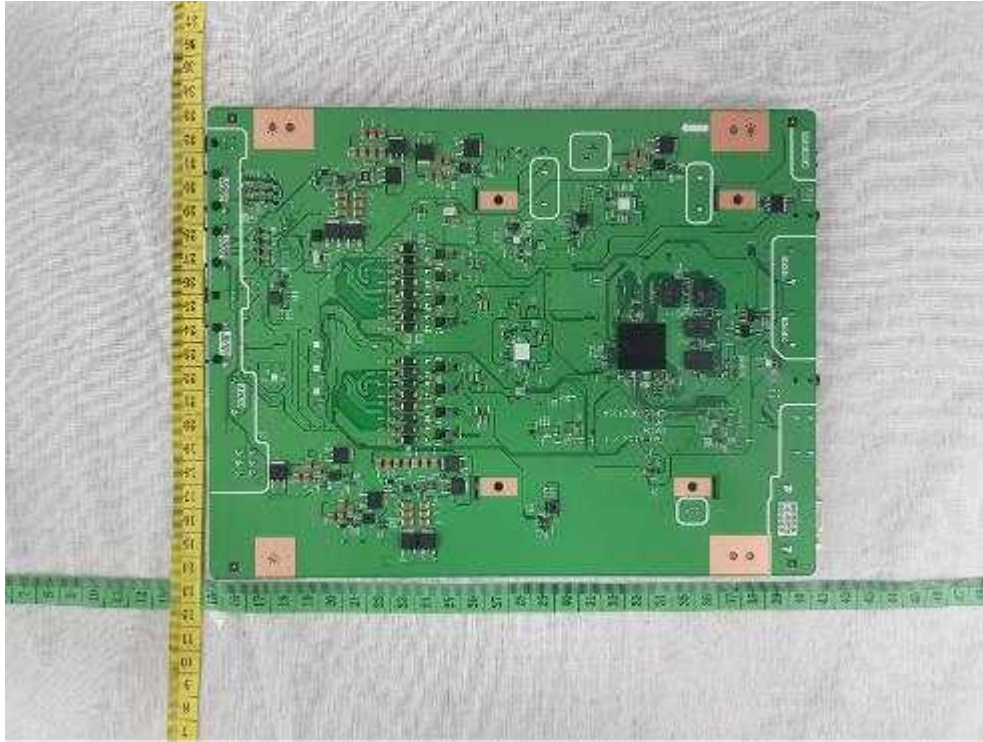


< Main PCB top view >

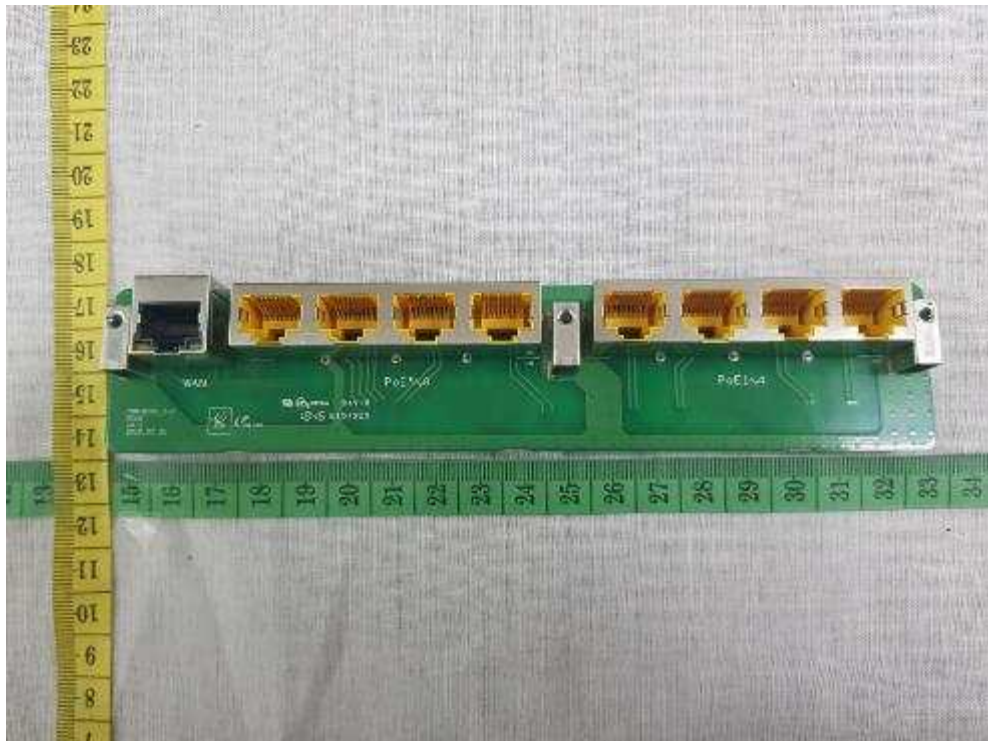

< Main PCB bottom view >

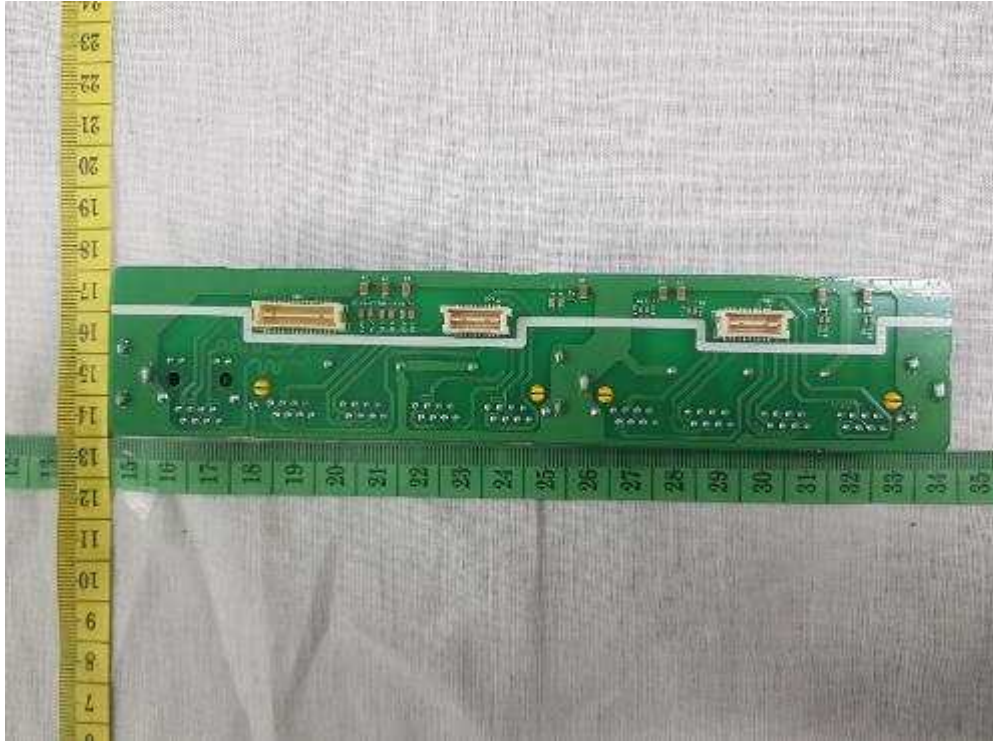


< PoE PCB top view >
